1. Triage and prioritisation

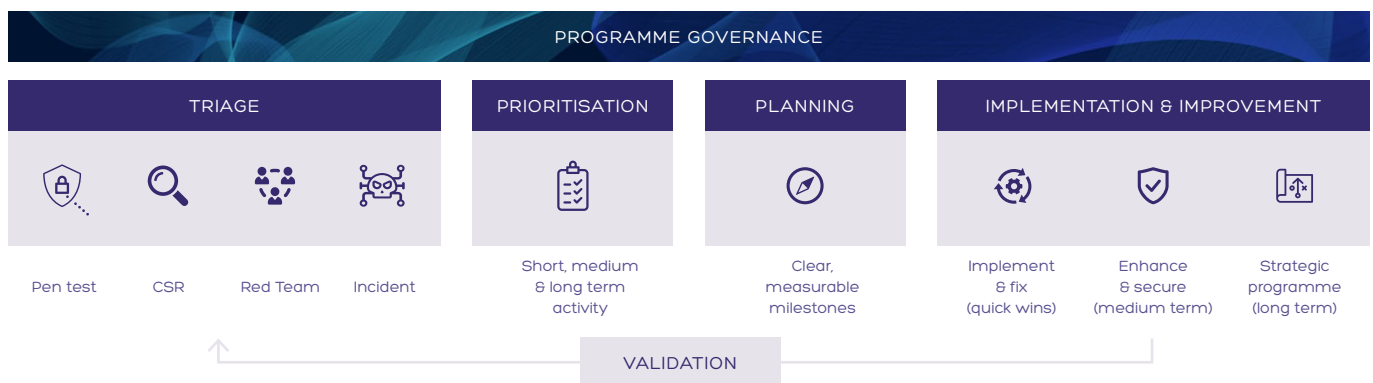
